PLATINUM*

A ten (10) year, one time commitment of \$5,000 to be paid in one lump sum or an annual sum of \$1,000 for 5 years, due by May 1st annually. A 4'x6' banner featuring your business name will be displayed at the Amphitheater Summer Movies/Music Series events for ten years.

*Includes one banner replacement at sponsor's request after five years.

GOLD

A three (3) year commitment of \$1,000 to be paid in one lump sum or an annual sum of \$333 for 3 years, due by May 1st annually. A 3'x5' banner featuring your business name will be displayed at the Amphitheater at all Summer Movies/ Music Series events for three years.

SILVER

A two (2) year commitment of \$500 to be paid in one lump sum or an annual sum of \$250 for two years, due by May 1st annually. A 3'x5' banner featuring your business name will be displayed at the Amphitheater at all Summer Movies/Music Series events for two years.
